WQUT's "DOLLYWOOD 40th Anniversary Giveaway" Contest Official Rules

A complete copy of these rules can be obtained at the offices of radio station WQUT ("Station"), owned and operated by Cumulus Radio LLC located at 162 Free Hill Road, Gray, TN 37615, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to WQUT, 162 Freehill RD Gray TN 37615.

The Station will conduct the **WQUT "Dollywood Ticket Giveaway"** Contest(the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. No purchase is necessary to enter or win. A purchase will not increase your chance of winning. Void where prohibited. All federal, state, and local regulations apply.

Eligibility. This Contest is open only to legal U.S. residents, excluding Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number and who reside in the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, who have not won a prize from the Station in the last thirty (30) days or a prize valued at \$500 or more in the last six (6) months and whose immediate family members or household members have not won a prize from the Station in the last thirty (30) days or a prize valued at \$500 or more in the six (6) months. **Void where prohibited by law.** Employees of Cumulus Radio LLC, its parent company, affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, other radio stations serving the Station's DMA, and the immediate family members and household members of all such employees are not eligible to participate. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein.

- Contest Period. The Contest entry period will begin at 10:01 a.m. ET on April 14th 2025 and will run weekdays from 10:01 a.m. ET through 6:59 p.m. ET on May 2nd, 2025 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- How to Enter/Win.

<u>On-Air</u>: During the Contest Period, listen to the Station weekdays from 10:01 a.m. ET to 3:00 p.m. and 3:01 p.m. to 7:00 p.m. ET during the Contest Period (each a "Contest Round") for the "cue to call." When Station announces to call in now" during a Contest Round, listeners should call the Station at 423.477.1015. Caller ten (10) to the Station, as determined by the Station in its sole discretion, will win be a potential winner of a Prize after providing the Station the listener's name and phone number, subject to verification and compliance with these Contest Rules. All entries may be played on the air. <u>Time Delay Between Over-the-Air Analog Signal and Internet Broadcast</u>: Due to the time delay that exists between the Station's analog over-the-air signal and

the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.

- Winner Selection. Each weekday during the Contest Period, Station will announce one (1) "cue-to-call" from 10:01 a.m. ET to 3:00 p.m. and again 3:01 p.m. to 7:00 p.m. ET during the Contest Period. Caller ten (10) as announced by the Station will win a Daily Prize subject to verification of eligibility and compliance with the terms of these rules. Winners will be notified at the time of the call. Station's decisions as to the administration and operation of the Contest and the selection of the Prize winners are final and binding in all matters related to the Contest. Winners will be notified at the time of the call and/or contacted using the phone number provided to Station. Station's decisions as to the administration and operation of the Contest and the selection of the Prize winners are final and binding in all matters related to the Contest. Winners will be mailed a liability/publicity release form to mail back to Station to redeem their Prize. Failure to claim the Daily Prize within fourteen (14) days of winning will result in disqualification and forfeiture of the Daily Prize.
- Verification of Potential Winner. THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner will be required to sign an affidavit of eligibility and a liability/publicity release (except where prohibited) in order to claim his/her prize, if applicable. A winner who signs the affidavit of eligibility and the liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize.
